MASSACHUSETTS LIBRARIES NEED MORE FUNDING.

Not everyone has high-speed Internet in their home—just ask the folks who live in western MA and parts of the Cape, where libraries are the only place for residents to access high-speed Internet. This doesn't just impact these areas. Only 3 of the 370 Massachusetts Public Libraries meet the national bandwidth standard set by FCC and many residents depend on their library's Internet. In fact, 27,622 people use the Internet every day in Massachusetts Libraries. Libraries rely on one of the nine Automated Library Networks for most cost-effective connectivity, but state funding cuts have left networks unable to make improvements to network infrastructure that will increase Internet speed. Competing in the 21st century requires 21st century speed.

State funding to support Massachusetts Libraries is lower than it was in 1998.

The increase will be used to meet rent and payroll and the legal financial obligation to fulfill union staff wage increases. Funding is currently at 1998 levels and supports a small staff that runs statewide programs and services, including Public Library Construction.
7000-9401 State Aid to Regional Libraries (Massachusetts Library System - MLS)	\$17,623,954 (FY 2002)	\$9,883,482 ↓ 44% from high \$7,381,599 (MLS)	\$8,196,599 (MLS)	\$1,065,188 (MLS)	Statewide delivery, which delivers 6.4 million items each year that residents request from other libraries, is in crisis. The increase will stave off delivery reductions to 25 libraries and prevent the elimination of Saturday delivery to 75 libraries. Each item is delivered for less than the cost of a postage stamp.

Increase will support access to 500,000 audio and braille titles and to materials on digital cartridges; facility cost increase; and staffing cost.
7000-9501 State Aid to Public Libraries	\$9,989,844 (FY 2009)	\$9,000,000 ↓ 10% from high	\$10,127,412	\$1,127,412	This is local aid for libraries that can be used in any way that supports the library. Many libraries use it to restore hours open, buy public computers, or fund capital improvements.
7000-9506 Library Technology & Resource Sharing (Library Networks)	\$4,420,235 (FY 2001)	\$2,076,564 ↓ 53% from high	\$3,259,000	\$1,182,436	Improve Network infrastructure to increase Internet bandwidth in more than 360 public libraries that are currently below FCC guidelines. Offset the cost of network membership for 328 libraries so that residents have access to materials from across the state— particularly important to residents in smaller communities whose libraries (162) participate in the Small Libraries in Networks Program.
